#### **Minutes from Fall Meeting:**

 Moved that minutes of the last meeting be accepted. Proposed by B. Chiarulli, and passed with minor edits.

## **President's report**: (Bev Chiarulli)

• Good year expanding PAC's presence. membership is growing, but we have budget issues. We need to find additional funding. Reach out to colleagues.

## **Treasurer's report:** (Lisa Dugas)

- Membership is increased with 10 new members.
- 41 paid members
- 5 donations for the poster totaling \$1500. Poster fee was \$900. The remaining money will be used for the poster next year and other programs.
- PAC had more expenses than previous years.
- PAC donated to/sponsored the PA Heritage Conference, the Farm Show and PA Land Trust.
- PAC separated the Workshops in Archaeology from the PAC account.
- Budget Passed. Bev motioned for approval.

#### Membership Committee: (Seth Mitchell)

- Encourage folks to renew membership and bring new members.
- Kira mentioned simplifying the application process to not include a CV.
- Ben Ford and Sarah Nuesius suggest having a form with check box/letter of interest.
- Ira Beckerman recommended developing a flyer to send around for promo.
- Gary Coppock suggested that PAC can become prestigious by having people join as a professional obligation, like RPA.

- Bev Chairulli mentioned RPA motion to have state Councils involved as a RPA organization, we didn't do that because we are less formal and not involved with litigation
- Marion Smeltzer recommended having more job posting to attract members.
- Bev Chairulli mentioned corporate membership to increase members (we have to check the PAC Bylaws)
- Phil Neusius motioned membership committee consider various membership option and come together with a motion to add more membership levels (e.g. corporate, lifetime). Rick G. Seconded. Motion passed.

- Gary Coppock suggested a committee for the process. Single coordinator with committee members in different parts of the states.
- Sarah Neusius made the motion, Amanda Snyder second, to contact Lisa to see if there are folk interested in being a network of people involved. Motion Passed.
- Archaeology month poster: Jonathan Burns: Poster complete. We are getting it printed next week to distribute at Byways and coordinate with SPA to get them to chapters. SPA will produce the poster next year. Navarro and Wright will volunteer for 2019 (Rick G).

## Farm Show: (Kurt Carr)

- Added pertroglyph tracing for the kids.
- It was a good event even though attendance was down to 3,800 people.
- Can add PAC promotional materials to booth

- PAC increased support to \$300 toward Hatch Scholarships.
- 6 recipients this year.

## New State Historic Preservation Plan: (Hannah Harvey)

- Required by NPS.
- Public input needed for the future of preservation, and decision-making tool, resource needs.
- Looking for more input and establishing connections with organization like PAC.
- 10-12 statement list for establish action plan and objectives.
- 96 planning partners including PAC.
- Needing PAC to help distribute and put plan into action.
- Opportunities to participate in group meeting an in public or online.
- 67 archaeologists, 500 respondents are interested in archaeology (survey sent out in blog and newsletter).

- Add Angie's video to the PAC website. Permanent home is on the archaeology channel.
- Progress for grant funds for publication. No grants submitted to PHMC. We will try again. Looking for other grants for the publications. PayPal donations?
